

**FACTS****WHAT DOES UNIFI LENDING LLC d/b/a NOMAD CREDIT (“Company”) DO WITH YOUR PERSONAL INFORMATION?**

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>▪ Social Security number      and      Credit History</li> <li>▪ Income                                      and      Transaction History</li> <li>▪ Payment History                      and      Employment Information</li> </ul>	
How?	All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons Company chooses to share; and whether you can limit this sharing.

<b>For our everyday business purposes –</b> such as to process your transactions, maintain your account(s), respond to court orders and legal investigations, or report to credit bureaus	Yes	No

When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p> <p>However, you can contact us at any time to limit our sharing.</p>

What we do	
<b>How does Company protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
<b>How does Company collect my personal information?</b>	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>▪ Open an account or apply for insurance</li> <li>▪ Give us your employment information or apply for a Loan</li> <li>▪ Give us your contact information</li> </ul>
<b>Why can't I limit all sharing?</b>	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>▪ sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>▪ affiliates from using your information to market to you</li> <li>▪ sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account.
Definitions	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ Company has no affiliates.</li> </ul>
<b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>▪ Nonaffiliates we share with can include insurance companies, service providers, co-branded partners, retailers, data processors, and advertisers.</li> </ul>
<b>Joint marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>▪ Our joint marketing partners include companies such as other finance companies, banks, and insurance companies.</li> </ul>
Other important information	
<p><b>California and Vermont Residents:</b> We will not share your information with companies outside of Unifi Lending LLC d/b/a Nomad Credit except for our everyday business purposes, for marketing our products and services to you or with your consent.</p> <p><b>Vermont Residents only:</b> We will not disclose credit information about you within or outside of Unifi Lending LLC d/b/a Nomad Credit except as required or permitted by law.</p> <p><b>Nevada Residents:</b> Notice provided pursuant to state law.
